

## AMENDMENT NUMBER 2 TO AGREEMENT CNR01392 BETWEEN EDUCATIONAL & INSTITUTIONAL COOPERATIVE SERVICES, INC. AND PITNEY BOWES INC.

This AMENDMENT NUMBER Two ("Amendment") is made between Educational & Institutional Cooperative Services, Inc., 2 Jericho Plaza, Suite 309, Jericho, New York 11753 ("E&I") and Pitney Bowes Inc., 3001 Summer Street, Stamford, CT 06926 ("Supplier").

**WHEREAS**, E&I and Supplier are parties to an Agreement for Postage Meters and Related Mailing Equipment, Software, Services, Accessories and Supplies, dated May, 1, 2016 ("Agreement"); and

WHEREAS, E&I amended the Agreement pursuant to Amendment Number 1 on September 15, 2016

WHEREAS, the Parties wish to amend said Agreement to remove the DMT product line under the following terms and conditions; and

NOW THEREFORE, the Parties do hereby mutually agree as follows:

- 1. Pricing Schedule 1-2 DMT Catalog is hereby removed from the Agreement.
- 2. Except as provided in this Amendment, all other terms and conditions of the Agreement, as amended, remain unchanged and in full force and effect. This Amendment becomes binding when signed by both parties.
- 3.
