This **AMENDMENT NUMBER FOUR** ("Amendment") is made between **Educational & Institutional Cooperative Services, Inc.**, 2 Jericho Plaza, Suite 309, Jericho, New York 11753 ("E&I") and **Pitney Bowes Inc.**, 3001 Summer Street, Stamford, CT 06926 ("Supplier").

**WHEREAS**, E&I and Supplier are parties to an Agreement for Postage Meters and Related Mailing Equipment, Software Services, Accessories and Supplies, dated May 1, 2016 ("Agreement"); and

**WHEREAS**, the Parties wish to amend said Agreement under the following terms and conditions; and

**NOW THEREFORE**, the Parties do hereby mutually agree as follows:

1. E&I and Supplier mutually agree that Amendment Number 3 is hereby deemed null and void and of no force and effect as of December 4, 2019.
2. E&I and Supplier mutually agree to remove Pricing Schedule 1-5-PB Software Catalogue from the Agreement.
3. Except as provided in this Amendment, all other terms and conditions of the Agreement, as previously amended, remain unchanged and in full force and effect. This Amendment becomes binding when signed by both parties.
4.
