# **SECTION 4: FIRST AID MEASURES**

#### 4.1 Description of First Aid Measures

# SECTION 11: TOXICOLOGICAL INFORMATION

## 11.1 Information on Toxicological Effects:

**Eyes:** May cause minimal irritation. **Skin:** No adverse effects expected.

**Ingestion:** No adverse effects expected. This product is not acutely toxic by ingestion. **Inhalation:** Could be a route of exposure, but unlikely under normal use. Inhalation of toner powder may cause mucous membrane and respiratory irritation. Prolonged and repeated overexposure may cause lung damage.

#### **Acute Toxicity Values:**

No data available

Irritation: May cause mild eye irritation.

**Corrosivity:** This is not a corrosive product.

**Sensitization:** This product is not expected to cause sensitization. None of the components are respiratory or skin sensitizers.

## Specific Target Organ Toxicity:

Single Exposure: None known.

Repeat Exposure: In a study in rats of chronic inhalation exposure to a typical toner, a mild to moderate degree of lung fibrosis was observed in 92% of the rats in the high concentration (16 mg/m3) exposure group. A minimal to mild degree of lung fibrosis was observed in 22% of the rats in the middle (4 mg/m3) exposure group. No pulmonary change was reported in the lowest (1 mg/m3) exposure group, the most relevant level to potential human exposures.

**Carcinogen Status:** None of the components greater than 0.1% are classified as a carcinogen by IARC, OSHA, NTP, ACGIH, or the EU CLP.

**Germ Cell Mutagenicity:** This product is not expected to be a mutagen.

**Toxicity for Reproduction:** This product is not a reproductive hazard.
