#### 4.1 Description of First Aid Measures

#### 11.1 Information on Toxicological Effects:

Eyes: May cause minimal irritation.

**Skin:** No adverse effects expected. **Ingestion:** No adverse effects expected. This product is not acutely toxic by ingestion. **Inhalation:** Could be a route of exposure, but unlikely under normal use. Inhalation of toner powder may cause mucous membrane and respiratory irritation. Prolonged and repeated overexposure may cause lung damage.

#### Acute Toxicity Values:

**Corrosivity:** This is not a corrosive product.

**Sensitization:** This product is not expected to cause sensitization. None of the components are respiratory or skin sensitizers.

#### Specific Target Organ Toxicity:

Single Exposure: None known.

<u>Repeat Exposure</u>: In a study in rats of chronic inhalation exposure to a typical toner, a mild to moderate degree of lung fibrosis was observed in 92% of the rats in the high concentration (16 mg/m3) exposure group. A minimal to mild degree of lung fibrosis was observed in 22% of the rats in the middle (4 mg/m3) exposure group. No pulmonary change was reported in the lowest (1 mg/m3) exposure group, the most relevant level to potential human exposures.

**Carcinogen Status:** None of the other components of this product at greater than 0.1% are classified as carcinogens by IARC, OSHA, NTP, ACGIH, or the EU Regulations.

Germ Cell Mutagenicity: This product is not expected to be a mutagen.

Toxicity for Reproduction: This product is not a reproductive hazard.
